Signing In

LexConnect is available to purchase for existing Standards On-Line clients as an add-on. To access **LexConnect**, go to <http://www.saiglobal.com/online/>, enter your user ID, Password and Username and click Submit. This will log you into Standards On-Line, which will also automatically log you into **LexConnect**. There is no extra software needed and no additional logins required.

Search Results

The **Search Results** in Standards On-Line will provide an indication of whether an Australian Standard® is referenced in Australian legislation. In the column titled 'Australian Legislation', a **LexConnect** icon will be visible if the Standard is referenced.
